DO I QUALIFY?

- Individuals and families with minor age children (0-17) struggling financially
- Families that are currently receiving SNAP, SSI, SSD, unemployment benefit, Medicaid cash assistance
- Senior citizens, 62 years or older, struggling financially and/or receiving social security income only

WHAT DO I BRING?

- Photo I.D. for applying adults
- Social Security cards or birth certificates for individuals, spouses, and minor children in the household
- Grandparents need legal proof of custody of grandchildren
- Proof of benefit (SSI, SSD, SNAP, Section 8) award letter or unemployment benefit
- Current utility bill (electric, water) or lease agreement as proof of residence

¿CALIFICO?

- Familias y personas con hijos menores de edad (0-17) que tienen dificultades financieras
- Familias que están recibiendo beneficios de SSI, SSD, SNAP, Medicaid, asistencia en efectivo o desempleo
- Personas de 62 años o más luchando financieramente
- Las personas mayores que viven del Seguro Social como su única fuente de ingresos

¿QUÉ DEBO LLEVAR?

- Identificación con foto para adultos que aplican
- Tarjetas de Seguro Social o Certificado de Nacimiento para los niños menores en el hogar
- Abuelos necesitan prueba de custodia legal sobre los nietos
- Prueba de SSI, SNAP, SSD, Sección 8 carta de verificación o las prestaciones por desempleo
- Factura de servicios públicos (electricidad, agua) -o- acuerdo de arrendamiento en su nombre
