As a guest of a Fivay High School student, I understand the following:

- ✓ All guests must comply with all school and district Code of Conduct requirements. Students must be in Pasco County Dress Code to attend the dance.
- ✓ Students must be in good standing at their school.
- ✓ Guests must present a current school or government issued ID to enter dance.
- ✓ This dance is a tobacco, alcohol, and drug free event. The use of drugs, alcohol, or tobacco products is NOT permitted. Guests are prohibited from being in possession of any type of weapon, including any look-like weapon.
- ✓ Age-appropriate dancing is expected. Inappropriate dancing will not be tolerated. This includes grinding, grind trains, bending over, straddling legs, lap dancing, etc. Inappropriate touching is also prohibited. Students who break this rule will be asked to stop. If students continue to break rules or are non-compliant, they will be asked to leave, and parents will be contacted. The lights will be turned up and/or music changed as a collective warning for everyone. Appropriate dancing includes hands on waist or shoulders only, both feet on the floor, and respectful public displays of affection. Any violation of school rules including inappropriate dancing may result in your immediate removal from the event and may result in disciplinary action, in accordance with school policy.
- ✓ FHS reserves the right per the Student Code of Conduct and statute, upon reasonable suspicion to search all cars, party buses, and limos, as well as purses and other belongings. All students and guests are subject to search. Outside food and drink are not permitted.
- ✓ Students and guests are not allowed to re-enter the dance upon leaving.
- ✓ Students and guests must vacate the premises within 30 minutes (10:30 pm) of the dance ending.
- ✓ Students and guests will be removed from the premises with no refund for improper conduct, violations of rules, and/or refusal to comply with requests from staff and chaperones.
